(Excerpt from the Law on Higher Education)

#### **University** (article 33 of the Law)

University is an independent higher education institution which in conducting activities consolidates educational and research, professional, and artistic work as components of the unique process of higher education.

University can accomplish all types and levels of studies.

Higher education institution has a status of university if it accomplishes academic study programs at all study levels, within at least three fields and three branches pursuant to article 27 of this Law.

Extraordinarily, university can be founded in the field of arts if it has all three study levels from at least three branches of arts.

Faculty and Art Academy (article 34 of the Law)

Faculty, respectively art academy, is higher education institution, respectively higher education unit in the structure of university, which accomplishes academic study programs and develops research, professional, respectively artistic work in one or more branches.

Faculty, respectively art academy, may accomplish vocational study programs.

Faculty, respectively art academy, in legal transactions appears by the name of university whose part it is and by its own name, pursuant to university statute.

**Organization of higher education institution** (article 47 of the Law)

Organization of higher education institution is effected according to statute, in accordance to Articles of Incorporation and this Law.

Independent higher education institution establishes higher education units as forms of internal organization, in accordance to statute.

According to Articles of Incorporation of higher education institution the status of higher education unit is defined concerning the right to act in legal transactions and business, the disposal of material resources, managing, deciding, and other important issues concerning higher education institution's work are arranged.

Academy of vocational studies has in its structure departments and sections in order to accomplish study programs from related branches, research and artistic work, as well as more effective use of resources.

University may have in its structure faculties, art academies and other higher education units as a legal entity.

Faculty, respectively art academy is a legal entity if it accomplishes at least three approved, respectively accredited study programs.

Decision on the change of the status, the change of the name and the location of higher education institution which is a part of university as a legal entity is made by university authorities with a two-thirds majority.

Higher education institution may found higher education unit outside its headquarters, without legal entities, article 16 proceedings of this Law.

Faculty, respectively art academy, as well as other higher education units as legal entities, arrange internal organization and managing of its statute, in accordance with the university statute.

University approves the statute of higher education unit which is in its structure.



#### Integrative function of university and other independent higher education institutions (article 48 of the Law)

Statute of higher education institution, Articles of Incorporation of higher education unit and general acts of higher education unit establish authorization and way of managing which ensure unique and harmonized higher education institution's activity.

University integrates functions of all institutions and units which are in its structure, especially faculties, by practicing uniform policy whose aim is constant improvement of quality of teaching, perfecting of research work and artistic creativity.

In order to accomplish objectives from section 2 of this article, university, respectively academy of vocational studies, has a particular jurisdiction in the following fields:

1. establishing uniform work standards for offices and services and uniform standards for establishment of a database of all units;

- 2. strategic planning
- 3. adoption of study programs
- 4. assurance and quality control
- 5. enrollment policy
- 6. election of teachers
- 7. issuing of certificates and appendices to certificate
- 8. international cooperation
- 9. investment planning
- 10. employment policy planning and recruiting of teachers and associates
- 11. forming and developing a uniform information system
- 12. lifetime education

Higher education unit has the right to give suggestions concerning issues from section 3 of this article, the way it is arranged by university statute.

#### **Bodies of the higher education institution** (article 50 of the Law)

Bodies of the higher education institution are arranged by the Statute of the institution, in accordance with the Law and Articles of Association.

Higher education institution has a managing body, management body, professional body and student parliament.



### **Managing body** (article 51 of the Law)

Managing body of higher education institution is the council. Number of the members of the council is odd. The number of members, the selection procedure and resolution of the council members, work methods of the council and decision-making are arranged by the Statute of the higher education institution. The mandate of council members lasts for three years. The council member can be a member of the managing body of just one higher education institution.

#### **Council's jurisdiction** (article 53 of the Law)

Council:

- 1. makes statute, as proposed by the managing body;
- 2. elects and resolves the management body;
- 3. makes financial plan as proposed by professional body;
- 4. adopts report on operations and annual financial reports as proposed by professional body;
- 5. adopts a plan of using funds for investment as proposed by professional body;

6. gives consent for decisions on asset management of higher education

institution;

- 7. gives consent for the distribution of funds;
- 8. makes decisions concerning the tuition fees as proposed by professional body;
- 9. gives business report to the founder at least once a year;
- 10. passes a general act on disciplinary responsibility of students;
- 11. elects an external auditor of the financial management of the higher education institution;
- 12. performs other tasks in accordance with the law and the statute.

Concerning questions from section 1 of this article council decides by majority vote of total number of council members.

The statute of higher education institution defines professional body which arranges proposals referred to in section 1 of this article.

Senate defines the proposals from section 1 of this article for the university and for the faculty, respectively art academy, respectively teaching -artistic council.





#### **Rector** (article 46a)

The management body of the University is rector.

Rector is elected by Council from among full-time professors of the University who are employed full-time.

Rector is elected for three years, with the possibility of re-election.

#### **Rector's jurisdiction** (article 47)

Rector represents and presents the University.

Rector shall have all powers necessary to enable him to perform his duties within its jurisdiction, and in particular to:

- propose business policy and measures for its implementation;

- organize, harmonize and manage the work and business of the University and its organizational units;

- chair Senate;
- implement decisions and conclusions of the Council and Senate;
- conclude contracts on behalf of the University;
- order-issuing authority for the execution of financial plan
- signs: diplomas of the completed studies of the first, second and third degree;
- performs promotion of Doctors of Sciences and Honorary Doctors;
- make decisions in the process of recognition of foreign higher education documents and evaluation of a foreign study program
- perform other duties stipulated by Law, Statute and other general acts of the University.

Rector of the University is autonomous in carrying out tasks within its purview.

Rector's mandate ends according to Law.

#### Senate (article 54)

Professional body of the University is the Senate. The Senate includes:

- rector,

- proctors (2),
- deans (3),
- full-time professors (3)

When discussing and deciding on issues related to ensuring the quality of teaching, the reform of study programs, analysis of the efficiency of study and determining the number of ECTS.

#### article 55

Mandate of the student representative is one year, with the possibility of re-election.

Membership of rector, proctor and dean in Senate lasts during their mandate.

#### article 56

The procedure for dismissal of members of the Senate is applied pursuant to the provisions of this statute on their election.

#### Senate's jurisdiction (article 57)

In realizing of its function Senate:

1. arranges general issues which refer to research, scientific and artistic work and teaching at the University

2. considers the strategy for the development of academic activities at the University, including es tablishment of new, changing or abolishing the

existing study programs and giving the opinion on these issues to the Rector and University Council; 3. prepares proposals of the study programs of interdisciplinary character or for more faculties at once and organizes execution of these programs at the University as a whole;

4. selects the academic and scientific titles

5. adopts the structure and content of study programs and courses;

6. makes decisions in the process of awarding the academic title of Master of Science and Doctor of Sciences

7. determines the nomination for the rector, along with the founder;

8. recommends students for admission and establishes criteria and procedures for enrollment in accordance with the law;

9. establishes policies and procedures for testing and evaluating the success of students;

10. ensures teaching and learning throughout life

Institute or other scientific research institution may accomplish part of accredited study programs of master's studies and PhD studies at university."

#### **SUBJECTS**

#### **INTERNATIONAL MANAGEMENT**

Aim of the subject is for students to achieve competence and academic skills in the field of international management which refers to managing operations abroad, coordinating activities in multicultural environments and conducting global interests. Students develop competence and specific practical skills which are necessary for the profession of international manager through lectures, practical management training and independent work. Students familiarize with the functioning of the world multinational companies, with a focus on companies from America and Japan, work of the board of managers and the top managers of these companies.

#### MANAGERIAL DECISION-MAKING

Within the subject Managerial decision-making basic forms of decision-making are studied through the role and influence of manager's level, manager's authority, the importance of information and communication and the influence of the environment on the process of making and implementing decisions. Basic models and decision styles are studied. Emphasis is put on practical application and the study of realistic situations through processing and analyzing business cases.

#### **ENGLISH LANGUAGE**

The developing of creative and practical skills and mastering practical skills of communication in a foreign language are necessary for the profession of an international manager. The aim of realization of this study program complies with basic tasks and goals of the Faculty of International Management.

#### **INTERNATIONAL BUSINESS**

#### **APPLICATION PROCEDURE OF MASTER'S THESIS TOPIC**

Eligible candidate submits request to the Senate of European University for the approval of master's thesis completion.

Candidate fills in an application form which contains general information about him.

An application form also contains master's thesis topic suggestion, which is previously adjusted with the mentor.

In addition to an application form, candidate encloses the following:

- commentary to the topic which includes:
- object and scientific goal of research
- general hypotheses
- methods to be applied in work
- content elaborated into theses
- literature to be used
- biography
- list of published vocational and scientific papers
- Certificate of Bachelors Degree
- birth certificate

#### **APPROVAL PROCEDURE OF MASTER'S THESIS TOPIC**

Upon receipt of applications for completion of master's thesis, the Senate of European University forms the Commission for preparing reports on eligibility of candidates and on scientific validity of reported topic for master's thesis completion (within 7 days).

Commission consists of at least 3 (three) professors and researchers holding certain degree.

Commission delivers report to the Senate (within 15 days).

According to the delivered report of the Commission, the Senate of European University makes decision on approval of reported topic completion and appoints mentor to a candidate (within 7 days).

Mentoring can be done only by a professor who is employed full-time or part-time.

After making decision on approval of topic by the Senate and appointing mentor, candidate takes up master's thesis completion.

Candidate – postgraduate will have the right to defend master's thesis by the end of school year 2013/2014.

When candidate accomplishes master's thesis preparation and when mentor accepts prepared master's thesis, he approves candidate to use it.

Bound master's thesis should correspond to set and prescribed standards of European University.

#### b) First page after the cover

Candidate submits five bound copies of master's thesis along with the request to the Senate to form the Commission for the assessment and defense of completed master's thesis.



#### **ASSESSMENT PROCEDURE OF MASTER'S THESIS**

The Senate of European University forms the Commission for assessment and defense (within 7 days).

The Commission delivers the report on assessment of completed master's thesis to the Senate (within 30 days).

After delivering the report of the Commission, the Senate accepts the report, then the master's thesis and the report of the Commission shall be made available to the public (announcing in public deadline 30 days).

If in the period of announcing in public has not been any remarks on the report of the Commission nor on the master's thesis itself, the Senate of European University adopts the Commission's report and approves the oral examination of the thesis to the candidate – postgraduate in front of the formed Commission.

European University informs the public on the date of the oral examination of the master's thesis. (The date is set in agreement with the candidate, mentor and the members of the Commission).

#### THE ORAL EXAMINATION PROCEDURE OF MASTER'S THESIS

The Commission for master's thesis oral examination formed by the Senate elects the president who opens public oral examination of master's thesis and presents information on candidates and procedure of master's thesis completion.

One of the members of the Commission reads the Commission's report on the assessment of the completed master's thesis and then the president gives candidate - postgraduate the floor to present his master's thesis within 20 to 30 minutes together with conclusions obtained through research work.

When the candidate's presentation is ended, the president gives floor to the members of the Commission and mentor to question the candidate.

When the oral examination of master's thesis is over and when all questions are answered, the Commission withdraws to make a final decision.

Taking into consideration candidate's presentation, answers to the questions asked as well as the master's thesis itself, the Commission makes decision and informs that candidate «defended» or «did not defend» his master's thesis.

A person who defended its master's thesis pursuant to article 123 of Law on Higher Education of Republic of Serbia ("Official Gazette RS" No.76/2005, 44/10) is awarded the title of Master of Sciences.

When master's thesis is defended the right of promotion is acquired.

The promotion of Master of Sciences is done by rector of European University. Promotion is held once a year.

Aim of the subject is to acquaint students with the role of international accounting standards (IAS) in terms of their function in international management and business. The study of IAS as instruments which should enable and facilitate the process of globalization. Understanding of IAS significance, single objective purpose of each standard as well as their practical use.

#### **BUSINESS ENGLISH LANGUAGE**

Adopting linguistic competence for using foreign literature with the aim of introduction with scientific achievements in the world. Deepening of communication competence with the aim of effective oral and written communication in scientific research and professional work of candidates in the field of scientific management – international management.

Optional subjects:

#### **INTERNATIONAL FINANCES**

Term, content and significance of international finances. Financial decisions of managers in international business. Foreign exchange management in international business. International financial, monetary and banking system. International financial markets and the process of creating a unique European financial market. International movement of capital. Systems and methods of payment in international business.

#### **INTERNATIONAL ECONOMY**

World economy, economic flows in the world and participants, theoretical basis of international economy and trade, integration, globalization, regionalization, global regulation of world economy flows, trading policy of developing countries and strategic trade policy, instruments of trading policy, non-tariff barriers, political economy of international economic relations, financial aspects of world economic flows, the most famous modern schools of economic diplomacy, decision-making in economic diplomacy, practical models of economic diplomacy, negotiations in economic diplomacy and international business (macro and micro aspect) and characteristics of economic diplomacy in Serbia and its development perspectives.

#### LOGISTIC MANAGEMENT

Course content includes 15 teaching units as follows: Frameworks of logistic management, Logistics and management of supply chains, Logistic activities and logistic challenges, Customer service, Logistic information system and technology, Purchasing and procurement, Concept of stocks, Management of materials, Transport, Storage, Material handling, packing and reverse logistics, Organization of effective logistics, Financial performances of logistics, Global logistics and Logistics strategy. Every teaching unit is supported by the adequate analysis of a case study.

A technique of scientific approach to management is very well established weapon for problem solving in most large organizations including civil and military state institutions. These techniques are used in activities such as capital budgeting and managing of cash flows, production planning, development of production strategies, planning of development programs for staff, maintaining optimal levels of stock and planning air traffic. In spite of wide application in problem solving, its major contribution to management is in planning control activities and good progress is also reached in the spheres of organization, staff and the management of organization.

#### METHODOLOGY OF SCIENTIFIC RESEARCH

Subject structure is based on studying globalization and global business. Special emphasis is put on consideration of global business issues, global business management and the unique concept of globalization. Despite this, it studies market and industry globalization, and in particular current and future trends in globalization. It also deals in transnational management, business, protagonists and international organizations in global politics. Special attention is given to problems in the environment as well as the usage of value chains. Global logistics and diplomacy are also processed as valuable components of globalization. As especially important elements of globalization and process of globalization, global and transnational business strategies as well as focus strategy, strategy of technology and management of expatriates are processed. Through environmental analysis and comparison of nationalism and globalization another segment of globalization is processed.

#### **INTERNATIONAL ORGANIZATIONS**

Main goal of this study program is the study of international non-governmental and governmental, business, commercial and financial organizations. In this course the United Nations, the Security Council, OSCE, NATO, the European Union, the European Council, WTO, IMF, OECD are especially studied, and special emphasis is put on the study of multinational and transnational companies.


