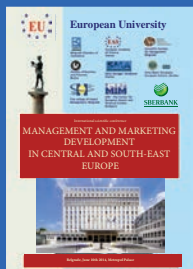


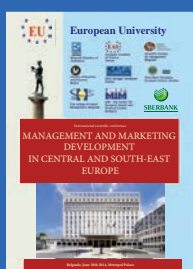

Academician Prof. Dr. Dr. h.c. Peter Linnert studied economics and business administration at the university of hamburg. He has been awarded doctoral degree of economics and business administration in 1964 (Dr. rer.pol.).

Afterwards he worked as tenured track assistant professor at the institute of banking business at the university of hamburg.

In 1969/1970 Academician Prof. Dr., Dr. h.c. Peter Linnert started lecturing at the Vienna University of Economics and Business Administration.

Academician Prof. Dr., Dr. h.c. Peter Linnert published more than 25 books. With his two volume work “die neuen Theorien des Marketing” first edition in 1969 he contributed essentially to dispersion of marketing philosophy in the german speaking part of Europe. Among others he published the “Handbuch Organisation” and the “Handbuch Verkaufsförderung” presenting sales promotion for the first time as a modern instrument of marketing politics.

Passing several stations of lecturing at different universities in Germany and abroad he was appointed director of the institute of management of the university of Merseburg.

At the same time he held a chair at the Technische Universität of Vilnius. During his term of office in Vilnius he contributed essentially to the structuring of the faculty of economics and business administration in Vilnius. The faculty of economics and business administration therefore awarded Academician Prof. Dr., Dr. h.c. Peter Linnert “honorary doctor” in 1994 for his scientific work.

In 1996 started started as CEO of “Service Management Seminare an der Wirtschaftsuniversität Wien” which he reorganized to “Sales Manager Akademie (SMA)” in 1999.

SMA has been awarding among others the master degree of business administration to top level managers and high potentials since 2000 and founded the “Studienzentrum Hohe Warte (SHW)” in 2006. In cooperation with european universities, SHW offers undergraduate, graduate and post graduate studies of economics and business administration in german language.

Academician Prof. Dr., Dr. h.c. Peter Linnert has written critical statements to many questions in the fields of economics and business administration in more than 70 publications. He is advisor of many well known service and industrial companies in Europe.

## *Dr. Vladimir Cizelj*

Vice president of European Academy of Science

Vladimir Cizelj was born on April 28, 1951 in Ptuj. He has been living in Belgrade since the age of five. Upon completed primary school, he finished secondary school of engineering “Nikola Tesla”. After completing his studies at the Faculty of Engineering, the University of Belgrade, Department for Electronics, Telecommunication and Control Engineering, he acquired the title of Master of Business and Administration in 1977 at the Bloomsburg University, Pennsylvania, the United States of America.

He first began working at the “Vinča” Institute of Nuclear Sciences, where he worked at the Laboratory for Theoretical Physics. He formed a department for development of special devices and systems (which still to this day is called “Cizelj’s”) and he manifested early his visionary qualities. His scientific contributions stood out in various significant and complex military projects.

In 1997 Cizelj founded in Belgrade the private company Vlatacom Ltd, as the representative of the Motorola company. He was given recognition for outstanding performance from the President of CEO, Motorola Inc; USA, 2002.

Since 2002, the company significantly expanded its activities to the integration of systems based on information and communication technologies, as well as to the development of software and electronic devices.

Generally speaking, the success of Vlatacom is the result of Vladimir Cizelj’s vision and continuous investment in research and development. As the most important result of Vladimir Cizelj’s scientific work is the fact that Vlatacom received two important recognitions from the Ministry of Education, Science and Technological Development of the Republic of Serbia: in 2011 it was accredited as the scientific research and development center and on July 07, 2015 it was accredited as the first technological private research and development institute in Nowdays, Vlatacom Institute conducts research and development and scientific work. In the course of future work and development of the Institute, Vladimir Cizelj determined that the highest priority is the development of human resources and their knowledge and skills.

Vladimir Cizelj made possible for the Institute to develop an intensive educational and scientific cooperation with other scientific and higher educational institutions in the field of international technology management such as, primarily, the European University in Belgrade. Mutual scientific projects are in progress with the University of Oxford, Florida Atlantic University, University of Brno, etc. Vlatacom will continue to intensify the scientific research activities, which is an essential prerequisite (Precondition) for successful business in the world market.

All what Vladimir Cizelj imagined in his visionary imagination he also applied in practice. His work in Serbia in the field of information and communication technologies in terms of international business management for the purpose of economic development is undeniable.

Vladimir Cizelj was awarded honorary doctorate by the European University, Belgrade.

## *Prof. Dr. Bojana Rilke* General secretary of European Academy of Science

Prof. Dr. Bojana Rilke was born in Osijek, Croatia, where she completed her primary and high school. She graduated from the Faculty of Law in Zagreb and from the Faculty of Economics in Osijek. She acquired her master of science degree from the Faculty of Law in Belgrade, having defended master thesis on prohibition of multinational company unfair competition. Prof. Rilke was awarded the degree of Ph.D. from the Faculty of Law in Osijek, after defending her dissertation in the field of financial law.

After her graduation in 1976, Dr. Rilke started her career at the Faculty of Law in Osijek where she participated in several scientific projects and conferences and seminars (Lovran, Opatija, Cavtat).

After moving to Belgrade, Dr. Bojana Rilke joined Inex-Interexport Holding Company, as an advisor to the Company President. While working in the economic sector, Dr. Rilke was involved in scientific work as well, and published a number of scientific and professional papers.

The President of the European Academy of Informatization, the President of the World Information Distributed University and World Distributed University; The Grand Master of the World Order “Science. Education. Culture”; Eduard Evreinov is famous for his work in informatics, especially for his development for an area of study focusing on homogeneous Computing systems, structures and mediums. These results were commended by Lenin prize (N° 2), the highest scientific award in the world at that period of time (1957). He is academician of many international academies of sciences and is given the highest scientific title of “The World’s Elder in distributed information processing”.

Academician Evreinov is awarded numerous awards, orders, prizes, medals, diplomas and he is given many honorary degrees and titles. Prof. Evreinov is famous for his work in informatics, especially for his development of an area of study focusing on homogeneous Computing systems, structures and mediums. His theoretical and practical research has opened the door to increasing productivity and reliability of computation media, at the same time providing a reduction in the unit cost of resources calculated. His model of collectivity appears suitable for use in designing complex information systems in communications, energy production and transportation. At the beginning of the fifties of the 20-th century he developed and practically implemented complex electronic models for solving important problems and proposed methods for programming complex problems based on using of computers memory for realisation of associative tables. The problem of high and super high performance of automata was theoretically and practically solved by him at the end of 1956. These results were commended by Lenin prize (No 2), the highest scientific award in the world at that period of time (1957).

From 1959 to 1972 as deputy director of the Siberian Institute of Mathematics of the Academy of Sciences, he supervised works for solving complex problems. For the first time, it was shown and approved the using computers not only for mathematical problems, but in all spheres of human activity for informatisation society. These results were used for automation of computing works in national economic sphere under supervision of professor Evreinov as the general director of the United Institute, comprising of 31 local Institutes and 200 departments, as the chief of the problem - solving laboratory, as head of chair at University of communication and informatics from 1972 to 1993. From 1993 to the present prof. Evreinov has solved the problems of informatisation in the international field as the first vice-president of the International Academy of Informatisation and from 1999 as the president of European Academy of Informatisation.

During 55 years period of his scientific career academician Evreinov carried out important researches in the field of computer science, computer systems, discrete mathematics, remote telecontrol, digital electronic modeling, communications, theory and practice of distributed information processing technology using principles of parallel computations . Main results of research works conducted by professor Evreinov are represented in over 300 scientific papers, 25 monographs and 20 patents. Under his scientific supervision, 45 doctors (corresponds to Grand Ph.D.) and more than 250 doctors (corresponds to Ph.D.) obtained their degrees in the USSR. Numerous seminars, conferences, congresses and scientific centers on parallel

processing were organised and took place under supervision of academician Evreinov. Academician Evreinov combined research work with his own education and study in various universities and academies. He has M.S. degrees in communication, automation, computer science, mathematics, philosophy. He has Ph.D. degrees in computer science, mathematics and Grand Ph.D. degrees in computer science, physics and mathematics and information science. He is full professor and department chairman at numerous universities. He is also academician (member) of many international academies of sciences. He is given the highest scientific title of “the World’s Elder in distributed information processing”. Currently, academician Evreinov is involved in preparation and supervision of highest qualification specialists for the work of Information society development. He developed and introduced a two stepped education system for specialists to obtain doctoral (Ph.D) and Grand doctoral (Grand Ph.D) degrees. A Grand Ph.D degree is awarded to the doctors (Ph.D), who have written more than one hundred scientific papers, published three or more monographs, and participated in the preparation of 10-20 Ph.D in their field of expertise. Academician Evreinov is awarded numerous awards, orders, prizes, medals, diplomas and he is given many honorary degrees and titles.

(2) The Academy seat will be in Vienna and the scope of activity will be extended throughout the world especially to the European Union member states and other European countries.

(3) There is the possibility of establishing Academy subsidiaries.

## II THE ACADEMY GOALS AND TASKS

### *2 The Goal*

The Academy which activity is not profit oriented, will have the goal to:

- (a) Enhance the internalization of academic education and professional training;
- (b) Expand international relations in politics and economy in European country interpersonal relationships and the relations between European countries and the United States of America.
- (c) Strengthen the integration of Europe and the creation of a New Europe.

### *3 Attaining the Academy Goal*

- (1) Activities anticipated to attain the Academy goal include in particular the following:
  - a) Cooperation with national and international universities. Institutes, research centres, academies of science and organizations delivering educational and training programs of all degrees;
  - b) Accreditation of academic programs: BBA programs and undergraduate study diplomas, MBA programs, masters and doctorates in accordance with European (Bologna declaration) and American standards;
  - c) Organization of conferences, symposia and other economic gatherings oriented towards integration processes in Europe and throughout the world;
  - d) Publishing scientific and other professional publications;
  - e) Use of international contacts and the Academy member ties to make available information on study plans to the interested ones; keep evidence of faculty and supplying them with information;
  - f) Cherishing relationships between countries and well-known personalities in diplomacy and science;
  - g) Assistance to young professionals wishing to expand their professional and practical knowledge to appropriate environment, specially through information about it and assisting in academic education and professional training; if Academy financial possibilities allow for it, granting appropriate scholarships.

- (2) To achieve association goals the Academy will, in addition to others, cooperate with the following institutions:
  - a) European Association of International Business and Management, Budapest;
  - b) European University, Belgrade;
  - c) London Diplomatic Academy, London;
  - d) IMD -Institute of Management Development, Lausanne;
  - e) Hellenic Management Academy, Athens, Greece
  - f) Industrialists and Entrepreneurs Union of Russia, Moscow
  - g) ECBE – European Council of Business Education, Switzerland
  - h) Bohemia Foundation, Prague
  - i) Diplomatiska Akademie, Vienna
  - j) IMADec University, Vienna, Austria
  - k) Central European Academy of Science and Arts, Romania
  - l) Hotelfachschule, Opatija, Croatia
  - m) IFAM - Institut Franco - Americain de Management, Paris;
  - n) European Academy for Informatization, Brussels
  - o) American universities and academies of science.
- 3) The necessary funds will be provided through:
  - a) Admission and membership fees;
  - b) Income from events and association ventures;
  - c) Subsidies and other funds from international organizations, government bodies and other public institutions;
  - d) Donations, contributions, legacies and other funds made by domestic or foreign businesses, foundations or private individuals.

#### IV MEMBERSHIP, MEMBER RIGHTS AND OBLIGATIONS

##### 12 Types of Membership

- (1) Academy membership can be regular, special and honorary.
- (2) Regular members are those who fully participate in the Academy activities.
- (3) Special members are those who do not participate in the Academy activities but assist in its activity by paying increased membership fees or in some other specific way.
- (4) Honorary members are individuals the Academy Presidency nominated because of their special merits for the Academy.

##### 13 Membership

- (1) A member of the Academy can be any physical person, home and foreign legal entity, legally established private company or trusts or foundations. Physical persons as the Academy members are termed “Scientific Academic”.
- (2) The members of the Academy are eminent individuals, university professors, Grand Ph.D’s of Western Philosophy, distinguished diplomats, scientists and researchers in

science and education, as well as legal entities and prominent managers of respectable companies and governmental and non-governmental organization representatives.

- (3) The Presidency makes decision on regular and special member admissions based on the candidate application form. The admission can be denied with no explanation.
- (4) The proof of Academy membership is membership card with the date of the admission to the Academy.
- (5) Till the creation of the Academy, temporary admission of regular and special members will be performed by the founder or the Presidency if it has already been established. If the Presidency is formed after the Academy has been created, till then (definite) admission of regular and special members will be performed by the founders. The founders will invite the following organizations to become regular members:
  - a) Institute of International Management - MBA University Belgrade, Belgrade
  - b) European University of International Management and Business, Belgrade
  - c) Faculty of European Business, Belgrade
  - d) MIM - Manhattan Institute of Management, Paris- New York - Budapest
  - e) Mod'Art International, Paris - Shangai - Moscow
  - f) MIM - Management Center, Budapest

#### 15 Member Rights and Obligations

- (1) Members have the right to participate in all Academy events and to use the Academy institutions. Only regular and honorary members have the right to vote in the General Assembly.
- (2) Each member is entitled to request the Statute from the Presidency.
- (3) The general Assembly session is convened by the request of at least one tenth of membership and it must be held within four weeks of the date of request.
- (4) The Presidency must inform the members about the activities and financial conditions of the Academy at the regular General Assembly session. If one tenth of membership requests such information giving the reasons for it, the Presidency must give information within the four week period.
- (5) The Presidency must inform the members about the annual balance sheet auditing. If it is done at the General Assembly auditors must be included.
- (6) Members are bound, as much as they are able, to aid the Academy interests and they should not do anything that might endanger its reputation and purpose. They must respect the Statute and the body decisions. Regular and special members must pay their admission and membership fees on time, and in the amount determined by the general Assembly.

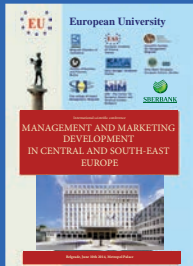

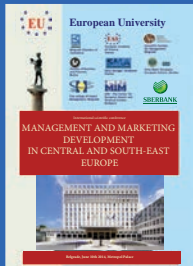
